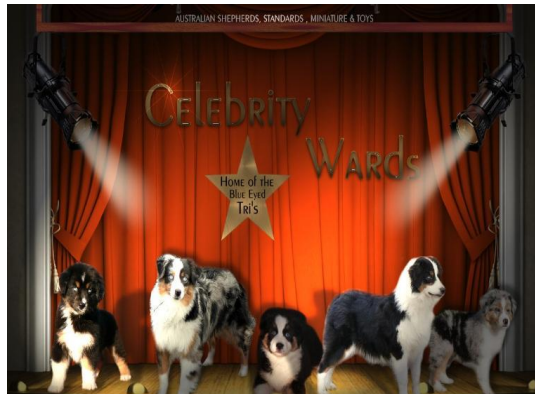

CONTRACT ON DOGS

Purchaser agrees to have their puppy examined by a veterinarian within 5 days of pick up or delivery. If the puppy does not pass the physical or has any serious health problems, you will then return the puppy with proof of problems for a 100% refund or another puppy when there is one available. I give a 2-year guarantee from purchase date against Hip Dysplasia and any life threatening congenital condition. I must see proof of existing problems from a licensed veterinarian or specialist. I will then have you spay/neuter your dog (pet or breeding dog). If you had purchased a breeding quality puppy, I will then give you another puppy from our next available litter same sex same color after you show proof of spay/neuter of the original puppy. You can keep your spay/neuter pet. But if you purchased a pet, this dog will still make life-long companion so I will refund \$300 to go towards medical bills and expenses. We, as breeders can only try our best not to produce genetic health problems by us testing the parents. **When registering any of my dogs through AKC or any other registry (i.e. MASCA, NAMASCUSA, ASDR, or NSDR), you must use my kennel name to register the puppy or dog. If my kennel name is not used, I will pull and void your health guarantee and there will be a \$1000 fine** Name _____

REASONS FOR 2 year GUARANTEE

I have been advised by a licensed vet that not only can a dog get hip dysplasia genetically but can also get it over time from jumping from the back of a truck, off stairs, beds, couches, running and slipping and sliding. I agree with the vet who told me this. Please do not allow your dog to jump or do agility until after 1 year. No one can guarantee any puppy from these problems so we are trying to make it right with everyone for we wouldn't want these problems to happen to us.

No full cash refund will be available after the 5-day agreement. Celebritywards will not be held responsible for any medical care or cost of the bill of new owners of said puppy. Celebrityward Kennels makes no guarantee that your puppy will make a show dog in the ring. It is your job to train your dog to be the best it can be. There is also no guarantee that it will be a good breeding dog, I'm not responsible for your breeding dog only having 1 puppy. It will be healthy when leaving my facility. Every puppy will be seen by a licensed vet and given their first shots, de-wormed, a complete health checkup, and tails docked and dew claws removed. All Breed quality puppies are evaluated for show/breed homes, but what you make of your puppy is not in any way reflect the quality you received from Celebrityward Kennels.

If purchasing a breeding quality dog, you agree not to breed THE FEMALE until she has had an OFA prelim (hips, elbows and patellas), a new eye certification and has reached 18 months of age. If bred before all health testing is completed and 18 mos of age, your health guarantee is null and void. A female puppy will be required to have her permanent/registered OFAs (hips, elbows, and patellas) completed after she is 24 mos of age. A male dog is allowed to breed at the age of 12 months in addition to all his OFA prelims done (hips, elbows, and patellas) and a new eye certification. During the first year of breeding, I do not want the male to be over used so he is allowed 3 breedings during the ages of 12 to 24 months. Over-breeding at a young age can cause injury. Once he has reached 24 months of age, he will need his permanent/registered OFA's (hips, elbows, and patellas) done along with a new eye certification. He is then free to breed as frequent as you feel is appropriate. If you are found to have bred a dog purchased from me before the puppy has reached it's age of breeding as stated above and hasn't had a OFA rating of fair or better (on both prelims and permanent xrays) along with its eye certifications, I will charge you a fee of \$5,000 and void your guarantee, **New Owner's signature _____**

If found that you purchased a pet quality puppy with NO breeding rights or you hard shipped any of my dogs into any registry, you will be charged \$5,000 and be responsible to appear in court in Chehalis, WA in Lewis County at small claims. Said dog would be returned to the breeder (Wendy Ward) with full papers, not altered, and if I have to locate, fly or travel to your location to retrieve said dog, you will be responsible for all costs in addition to all court fees. _____ **Initials**

If at any time you have difficulty providing for the dog that you purchase from me (Wendy Ward) and you wish to find another home for the dog, the dogs must be spayed/neutered and you need to send me proof of the spay/neuter along with info to contact your vet. If the puppy was placed with you as a pet, you then could place the puppy or dog in a good pet home. If the puppy was SHOW/BREED quality, said puppy would be offered back to me (Wendy Ward) first with full papers and unaltered. I will then give you back your \$500 breeding fee with in 60 days of dog coming back to me (Wendy Ward). If you need to place a pet quality puppy, I will offer you a service to place said dog on my website to help you place the dog as a pet. If it is found you have not full filled this agreement, I will have all rights to locate said dog, reposes him or her at your expense; including but not limited to, airfare and travel expenses to pick him or her up and all legal costs. If it is found that you have lied in any way with our contract or in what you have told me, I (Wendy Ward) can reposes the dog and you will be a fined \$5,000 and would be responsible for appearing in small claims court in my county; Lewis County, Chehalis, WA, 98532. I just want to know at all times were my dog will reside and that my dogs will be WELL CARED FOR. BUYER **Initials** _____

SPAY/ NEUTER AGREEMENT

Buyer agrees to spay or neuter the puppy by 8 months of age. Once complete, then with proof from a licensed vet who also states a microchip number on the papers, you will send them to me and in return get your application to register your puppy as pet. If the puppy is not spayed/neutered by 8 mos old, the health guarantee is null and void. You are still required as stated above for the life of the dog not to breed a pet. Registration application(s) will be given immediately on a show/breed quality dog. Once you have received your N.S.D.R, MASCA, ASDR, NAMASCUSA, AKC or ASCA papers, you can register with other clubs

- N.S.D.R NAMASCUSA, MASCA, AKC, ASDR applications for any standard, miniature or toy Australian Shepherd puppy if purchased as a breed quality puppy.
- Copies Eye Certification and OFA ratings on parents of the puppy
- Records of vet visits including vaccinations and de-worming on puppy
- Registration applications for pet quality puppies will be given after pets are spayed/neutered unless there is a box on application that I can mark as pet only, and then you will receive registration papers at time of purchase/pick-up
- all show puppies will be micro-chipped before going to there new home
- Copy of contract will go to all puppy buyers
